Agronomy Notes:

MZ 5134DBR starts with explosive seedling vigour. Plants have upright wide leaves. Flowering date is 2 days earlier vs MZ 5111DBR. Plants are taller with higher ears vs MZ 5111DBR. Ears are short and blocky with deep kernels. Ears have 18-20 kernel rows. Test weight is average. Husks are short and flare open. Position in and north of maturity zone under moderate populations. May respond to fungicide.
